SPOT-AUCTION NOTICE FOR DISPOSAL OF UNSERVICEABLE / SCRAP ITEMS



Unserviceable scarp/Scrap Items (Iron Scrap, German/Aluminum Scrap, Tina Scrap and Plastic & Mix Scrap, Battery scrap) of ICAR-National Institute of Biotic Stress Management, Baronda, Raipur (C.G) are to be sold / auctioned through public auction on **24.09.2024 at 11.00 am at ICAR-NIBSM, Raipur** under "**as is where is basis**" condition with the following terms and conditions.

1. The Unserviceable/Scrap items will be available on Auction "As is where is basis". The Unserviceable/Scrap items can be inspected by the interested parties through visiting the office on 20.09.2024 between 10.00 am to 4.00 p.m.
2. The bidders should Deposit an amount of **Rs. 2000/-** (Rupees Two Thousand) Only as Earnest Money Deposit (EMD) through Cash/Demand Draft only in favour of **ICAR NIBSM, Raipur** Payable at **Bank of Baroda** before the spot auction is started.
3. Participation will be allowed after submission of valid EMD before auction.
4. The amount of EMD deposited shall be adjusted from the total amount of payment due from the successful bidder.
5. The EMD of remaining unsuccessful bidder will be returned to them, without interest after finalization of sale / auction to the successful bidder.
6. No items, once disposed of from the successful bidder shall be taken back by this office on any condition whatsoever. Any uncleaned or unnoticed materials left over by the purchases within the premises cannot be claimed later.
7. The bidder should conduct due diligence on all aspects related to the property to his satisfaction.
8. The bidder shall not be entitled to make any claim against the authorized officer in this regard at a later date.
9. **The items shall be sold / auctioned to the highest bidders for all items together as one lot. Bidding for individual/partial items not allowed.**
10. **The reserve price for auction material would be opened and announced on the date of auction. Auction will be effective only over and above the reserve price.**
11. **The highest bidder should deposit the amount of the auctioned price on the same day before 5.00 pm.**
12. **The successful bidder must lift all the Unserviceable/Scrap items at his own cost within 5 working days between 10.00 am to 04.00 pm from the date of auction. There should not be any damage to the property of this institute / inconvenience in functioning.**
13. On failure of the successful bidder in paying the balance amount, the entire deposited amount paid by the bidder shall be forfeited without any notice.
14. **The firm/purchaser/participant submit the details as per the Proforma (Annexure-I) along with the copy of PAN No., GST No. & Aadhaar / Address Proof before auction.**
15. The undersigned will not entertain any claim for damage done by the way of theft, fire or any other unforeseen calamity after realizing full payment against the Unserviceable Material / items.
16. The successful bidder must lift all the Unserviceable Material / items at his own cost within 5 working days from the date of auction.
17. The Institute does not guarantee to make any definite quantity and quality of articles available to the buyer.
18. The list of items shown is indicative, ICAR-NIBSM Raipur reserves the right to add / delete / modify the quantity as found necessary.
19. The lifting of items must be done during working day office hours between 10 am to 4.00 pm only.
20. The lifting of the items shall be done without damaging the premises / roads / drains / etc. The buyer shall compensate the damages, loss, etc., in the event of any occurrence otherwise.

21. No selection or sorting whatsoever of the goods will be allowed. The entire lot should be cleared by getting proper Gate Pass from ICAR-NIBSM Raipur-493225.
22. The materials being disposed is to be treated in line with applicable rules / notifications / guidelines etc. as may be prescribed by the Government. The successful participant/firm shall be responsible to ensure this action.
23. Spot auction not complying with the above conditions are liable to be rejected.
